Make a Will Week in BC encourages residents to make or update their will. A will is a document that leaves instructions about what you want done with everything you own after you die and appoints someone to administer your estate. Personal planning documents, such as representation agreements and powers of attorney, appoint people to make financial, legal, and healthcare decisions for you in the event you become unable to make decisions yourself.
