

# **History of the BC Small Claims Rules**

The Small Claims Act came into existence in 1969 with the Provincial Court Act, SBC 1969, c.28, Part IV, s. 20.

However, it was not a new act. The act that existed prior to that time was the *Small Debts Court Act*, RSBC 1960, c. 359. The title of this act was changed to become the *Small Claims Act* by the *Provincial Court Act*, SBC 1969, c. 28, s. 36(2)(c).

The rules for the *Small Debts Court* continued on under the *Small Claims Act*. At this point, the rules were not a regulation. They are found in the body of the Act itself, RSBC 1960, c. 359, beginning at section 15.
